TRIAL SET UP/BUILDING HOURS:

- Set up starts at 7 am on Friday. We would greatly appreciate assistance with set up Friday morning. So that we may prepare for the trial as quickly as possible.
- On Friday from 7:00 AM to 7:30 AM only people helping with setup may enter the building. During this time, people helping may toss their mat down, but no crates should be setup until after 7:30.
- General building availability for all competitors is 7:30 on Friday.
- Saturday and Sunday building opens for all competitors at 7:00 AM
- The building closes 30 minutes after judging ends.

NO DOGS MAY BE LEFT IN THE BUILDING OVERNIGHT.

TRIAL AND SITE REGULATIONS, AVAILABILITY & CRATING

- Foothills is an on leash facility, please do not let your dogs potty in the landscaped areas or on the building.
- Paper Gate sheets will be used for check in and running. Results will be physically posted.
- Maps will be posted at <u>www.BrinsonTrialServices.com</u> the morning of each event. Posted map copies will also be available at the trial.
- Please clean up after your dogs. Walk your dog beyond the marker signs at each exit and stay off of mulched landscaped zones near the building. We can no longer use the grass area on the School Bus Property as a potty area. Do not take your dogs there to eliminate. Do not let your dog urinate on buildings or anything that a human may touch, and place poop in the proper trash can. Please clean up accidents IMMEDIATELY. Anyone observed not cleaning up after your dog, or allowing their dog run off-lead, will be asked to leave the trial site for the remainder of the weekend without refund. Please remember these courtesies should be extended to the hotels as well. Your cooperation in this matter is appreciated.

CRATING:

- · Clean, waterproof tarps must be under all mats, crates and EX-pens.
- Please be courteous with your set up. The aisle ways are narrow, and everyone should make an attempt to
 allow as much space for dogs and handlers to move about as possible. There is ample space available for
 crates and chairs, but not for extras like tables and excessive storage. The trial committee reserves the right
 to rearrange set ups if necessary to accommodate all participants.
- EX-Pens are permitted, but size should be appropriate to the number of dogs within.
- Please remember to keep the exit ways more open, as everyone must pass through these areas, and they should have a space that lets them be comfortable doing so.
- Please respect "NO CRATING" areas.

FOOD AND REFRESHMENTS AT THE TRIAL

- · No Food Vendor will be onsite for this event. Several food establishments are close by.
- Filtered water is available in the arena. Please bring your own water bottle.

MOVE UPS AND CLASS CHANGES

From Chapter 1, Section 20: Move-Up entries will be accepted for dogs that have completed a title after the closing date. Email notification of move up or class change is acceptable, with return receipt verification from the secretary. Either Move Up forms or emails must be completed and delivered to the Trial Secretary prior to 6 PM on the Monday evening preceding the event. Move-up entries for Saturday or Sunday must be delivered to the Trial Secretary within 30 minutes of the conclusion of judging of the class they are moving up from. Dogs so moved up will run at the end of the running order. Move-ups can only be accepted if judging limits are not exceeded. Entry move-up valid only if the dog was already entered in the Event indicated and only if approved by the Trial Secretary. Dogs moved up will run at the end of the class running order.

CONFLICTS

Please check-in every morning for EVERY CLASS. There will be boards posted with all the Gate Sheets for that day. Separating multiple dogs is allowed only if you keep them in the original order and, if possible, move the first dog up in the order. Any other reason for moving a dog MUST have the permission of the Judge! Judges are not required to wait for dogs. Be at the gate at least 4 dogs before your turn to go.

PARKING REGULATIONS

Exhibitors are governed by any rules or regulations of civil authorities and building and parking regulations. Vehicles parked contrary to regulations will be subject to towing at owner's expense. Parking in handicapped spaces is limited to those with handicapped permits. Please maximize parking spaces as much as possible by parking close to the car next to you and do not block other cars in.

Club officials may require that vehicles or equipment be rearranged to accommodate additional vehicles. Area around vehicles MUST be kept clean at all times. All vehicles will be parked at owner's risk. MHACOB will not be responsible for loss by burglary, fire, or any other cause whatsoever to the vehicle or its contents.

MHACOB TRIAL HOURS & SCHEDULE OF EVENTS

The trial site opens at 7:30am on Friday, 7am on Saturday and Sunday. Judges starts at 8:30 AM on Friday, 8 am on Saturday and Sunday.. The site remains open until 30 minutes after conclusion of judging.

Classes will be judged in the following order. Breaks may be called at the judge's discretion. Preliminary running order contingent on move-up entries not yet received and wait listed entry changes not yet received. (**Judges reserve the right to reorganize the schedule below to accommodate the needs of the trial**) "B" class dogs will run prior to "A" class dogs in the Novice classes, within height classifications, except where otherwise indicated. A warm-up area, consisting of a regulation agility jump, shall be provided for all exhibitors.
